LIGHTWEIGHT METAL MESH TUNIC FOR ARM AND BODY PROTECTION IN HAZARDOUS APPLICATIONS

- Steel ring wire diameter is .019" to provide a garment that is lightweight and comfortable
- Extended apron front with belly guard for added protection against knife stick
- Pull-over style, tunic has two full sleeves with metal snap cuffs
- Shoulder flap with snap closure to allow for easy donning and doffing
- Lightweight mesh rings are made of .019" wire, compared to the standard .021" wire, with no decrease in weld strength: .019" = 73.42 lbs of force, .021 = 67.08 lbs of force to pull apart
- US Mesh gloves and garments are compliant with FDA 21 CFR and safe for direct food contact
- Garments are made in compliance with the European EN1082 Standard

CARE INSTRUCTIONS

Keep in dry area. To clean, brush off any product residue and then wash with warm soapy water. Standard dish washing detergent is recommended. Hang to dry.
